

### From the Treasurer...

As an organization, SCCEC was able to weather the costs associated with two canceled conferences. Thanks to the leadership of former state officers, we had built the reserve funds to the point that allows us to continue operating in the black. Although we would not have chosen this course, we are moving forward.

SCCEC Conference 2023 was a success! While we do not yet have final figures, we are moving forward in a stronger financial position. The registration fees provided attendees with amenities such as the President's Reception, Coffee Break with the Exhibitors, Awards Luncheon, and Student Reception. Overall, the profits from registration fees allow SCCEC to pay operational expenses such as meetings, awards, insurance, newsletters, and national representation. We will also be able to begin rebuilding our reserve funds. But... before any profits are dispensed in this fashion, 5% of the conference profits are distributed to each of the award accounts. The award accounts include the Betty Brown Training and Assistance Grant, Mini Grants, and The Laura Mohr Scholarship. Once placed in these accounts the money becomes designated funds and is untouchable for any other purpose.

He has been a trailblazer with regard to innovative practices to improve the education and growth of exceptional needs students. Mr. Hayes' advocacy and support of exceptional needs students and their families is unparalleled. He is an exceptional role model for other principals in South Carolina. He is fully deserving of the South Carolina Exceptional Needs Principal of the Year Award."



Ms. Jessica Miller is a teacher of students with extensive support needs at Myrtle Beach Middle School in Horry County Schools. Her nominator, Ms. McDonald, stated "Being the instructional leader of a multi-grade, multi-adult classroom with students who have various cognitive, academic, behavioral, functional, and communication needs is not an easy task. Mrs. Miller embraces this challenge daily, and for that reason and more, she truly is an Exceptional Educator and deserves to be recognized as the SC CEC Exceptional Educator of the Year. Her impact goes beyond the instruction she provides to the students within her classroom; her team approach guides her influence on other students and staff within her building, across the district, and to the community as a whole."



Ms. Emily Scheffler is a special education teacher of students with extensive support needs at St. James HS, Horry County Schools. Her nominator, Ms. McDonald, stated "Emily works with multiple paraprofessionals with leadership skills that exceed her "rookie" status. All staff in the classroom follow detailed plans, work with various students, and have a positive attitude. The climate in the classroom is a reflection of her leadership as a teacher. Mrs. Scheffler's instruction moves beyond the classroom and occurs throughout the school environment and in the community. Her students participate in work-based learning at the high school, running a coffee shop alongside peers who are in the CTE program. Students who are ready to transition to employment experiences outside of the building are interning and/or working at local stores and organizations. Mrs. Scheffler has worked tirelessly to establish relationships with employers in the community who have become strong partners in student transitions from school-based enterprise to employment."



Morgan Harling is a junior at Lander University and serves as the vice president of the Lander University council for exceptional children. Her nominator, Dr. Collier, stated "she has assisted the Lander CEC in organizational meetings and fundraising activities while learning the duties of president before progressing into said role next year. Another remarkable accomplishment that Morgan achieved this year was the creation of an official Lander University American Sign Language club. Morgan created the club entirely herself: she wrote its constitution, completed all the paperwork required by Lander for club establishment, and coordinated the initial election of officers. Her peers unsurprisingly elected Morgan as president of this club, and since then, she has regularly conducted business meetings and led monthly ASL club meetings."
